**St. John's, NL October 3, 2023** - The Construction Labour Relations Association of Newfoundland and Labrador (CLRA NL) is pleased to announce that provincial collective agreements have been renewed with 17 construction trade unions in Newfoundland and Labrador. The agreements are for a five- year term and expire in April 2027.

"As the sole bargaining agent for all unionized employers engaged in the industrial, commercial and institutional sectors in the construction industry in Newfoundland and Labrador, we are pleased to have reached new agreements which support a productive, competitive and stable construction industry," said Chris Crotty, Chair of the Board, CLRA NL. "We wish to acknowledge the efforts of all parties for constructive discussions which have led to fair collective agreements, each which recognize specific union needs."
